Purse \$250,000 *CHURCHILL DOWNS S.(GRADE II) FOR FOUR-YEAR-OLDS AND UPWARD.* By subscription of \$250 each, which should accompany the nomination or by Supplementary Nomination of \$12,500 each at the time of entry. \$1,250 to pass the entry box; \$1,250 additional to start, with \$250,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights: 124 lbs. Non-winners of a Grade I stake since October 26 allowed 2 lbs.; a Grade I or II stakes since September 3, 4 lbs.; \$60,000 in 2008, 6 lbs. Starters to be named through the entry box at the usual time of closing. All supplementary nominations are required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, April 9, 2008 with 43 nominations. (Clear 65)

ELITE SQUADRON sprinted clear, set a fast pace near the rail, angled out a bit for the drive and drew off under steady urging.

NOONMARK within striking distance, steadied late on the turn in traffic, angled out a bit once in the stretch but lodged only a mild bid to be up for the place. HEWITTS bore out at the start bumping CARNACKS CHOICE and forcing that one out, was straightened to race close up in the three path, held on well to the final furlong and tired. ISLAND WARRIOR forwardly placed off the inside, lost position late on the turn then finished gamely to overhaul several rivals late. THOUSAND WORDS (GB) within striking distance along the inside, lacked the needed closing bid. JUNIOR COLLEGE forwardly placed along the inside, tired. CARNACKS CHOICE roughed at the start and forced out on SPOTSGONE, was far back to the stretch and rallied belatedly. SPOTSGONE carried out at the start, recovered to race within striking distance, moved to a forward position three wide on the turn but faded in the drive.
