ULTIMATE EAGLE broke alertly and sped to the early lead then came off the rail approaching the first turn, angled in and set the pace inside, responded when challenged on the backstretch, inched away again on the second turn, kicked clear into the stretch, fought back in midstretch, could not match the winner in the final furlong but held second. DOUBLES PARTNER saved ground chasing the pace, came out into the stretch and again in midstretch and finished well. JERANIMO chased between horses then outside a rival, went between foes again on the second turn, came three deep into the

stretch and was outfinished. TEMPLE'S DOOR pulled his way along three deep, was bumped and fanned out into the first turn, tugged and

steadied nearing midway on the backstretch, stalked outside or off the rail, angled in for the second turn and lacked the needed rally. TALE OF A CHAMPION also pulled and bumped a rival when fanned out some into the first turn, bid alongside the runner-up on the backstretch, tracked that one again on the second turn and weakened in the stretch. INTERACTION (ARG) a bit slow to begin, settled three deep then off the rail, went three wide again on the second turn and four wide into the stretch and could not offer the necessary response in the drive.
