**RES JUDICATA** disputed the pace outside **EDGE OF REALITY**, disposed of that one turning for home, was under brisk urging in the stretch and pulled away. **SOUPER KNIGHT** lacked speed, was three deep entering the stretch and rallied between horses. **CITY OF WESTON** chased the pace, was three deep turning for home, remained on his left lead and gave way. **EDGE OF REALITY** saved ground, dueled with the winner then gave way through the stretch. **ENGLISH MANOR** rushed up between horses down the backstretch, angled to the rail entering the turn, remained along the rail and faded. **DO IT FOR DON**, a forward factor early, circled the turn, was four deep turning for home and gave way. **PAPPA PORTMORE**, very wide straightening out for the drive, passed tired horses. **PERILOUS INDIAN**, wide on the turn, gave way. **FALLING SKY** stumbled leaving the starting gate, raced in the two path between horses on the turn and gave way. **PITCH N ROLL** hugged the rail and faltered.
