AARON'S WAY, lightly steadied behind **MR. WOOLLEY** near the three eighths pole, eased outside that one leaving the backstretch, swept to command on the turn then drew out under urging. **KING OF SCOTTLAND** circled the turn and finished gamely. **JUST YOUR WAY** bore in leaving the starting gate, lacked speed, swung out for the drive and rallied. **LEROY'S DEPUTY** raced inside horses in an even effort. **BANXIOUSFORNOTHING** lacked speed, saved ground around the turn, encountered traffic near the sixteenth pole then gamely rallied between rivals. **MR. WOOLLEY**, angled in midway down the backstretch, set the pace along the rail and faltered in the drive. **NICK'S MONSTER** was not a factor. **GATOR DONE**, wide leaving the turn, weakened. **SARATOGA DANCING**, forced in and back leaving the starting gate, was outrun and raced wide entering the stretch.
