The latter, reserved off the pace, swung out at the top of the stretch, rallied to reach COMMISSIONER nearing the sixteenth pole and continued on with good courage while being edged to the wire. HY KODIAK WARRIOR reserved off the pace, rallied to loom a threat in midstretch but couldn't gain late while up for the show. ICHIBAN WARRIOR set the pace along the rail to the sixteenth pole, then gave way. COUSIN STEPHEN stalked the pace off the rail to inside the eighth pole and weakened. SOLEMNLY SWEAR rated off the pace, steadied leaving the far turn when TOP BILLING swung out, then faltered. EASE ON BAI tracked the leaders three wide to the top of the stretch and faded.
