7 FURLONGS. (1:21¹) STAKES. Purse \$250,000 Commonwealth S. (Grade III) FOR FOUR YEARS OLD AND UPWARD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry (includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$250,000 guaranteed, of which \$150,000 to the owner of the winner, \$50,000 to second, \$25,000 to third, \$12,500 to fourth, \$7,500 to fifth and \$5,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I stakes since August 1, allowed 3 lbs.; a graded stakes since July 4, 5 lbs. The Commonwealth will be limited to fourteen starters. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest earnings in 2018-2019. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. Closed Wednesday, March 20, 2019 with 39 nominations. (Clear 67)

BOBBY'S WICKED ONE broke sharply and crossed over inside to the lead, set a pressured pace to the top of the stretch, hugged the rail edging away approaching the eighth-pole, and was kept to a steady drive. WARRIOR'S CLUB pressed the pace three wide from the start, had aim outside the winner turning for home, could not get by and saved the place. LIMOUSINE LIBERAL went along boxed in under a firm hold up the backstretch in the two-path, swung five wide late on the turn, and put in a grinding rally outside for a share. RECRUITING READY steadied inside past the six-furlong pole outsprinted to the front, remained hemmed in up the backstretch a bit antsy, was put to pressure still on the fence approaching the lane, and ran on one-paced. NEW YORK CENTRAL advanced mildly four wide around the turn, but flattened out in the stretch. MAJESTIC DUNHILL was devoid of speed for a half-mile in the two-path, moved out into the stretch and improved position while never a factor. UNO MAS MODELO was covered up behind and between rivals in the two-path early, and lacked a rally three wide into the stretch. UNCONTESTED was outkicked from the gate despite hustling tactics, saved ground and made no headway. STILL HAVING FUN was squeezed back between horses at the start, saved ground to the end of the turn, moved out widest in upper stretch and remained outrun. SUPREME AURA was driven three wide without response on the turn. RICHIESINTHEHOUSE pressed the pace between horses two wide, and faded soon after going a half-mile. RUNAWAY GHOST was in traffic toward the back early, and could not gain two wide on the turn.
