1¹/₂ MILE. (Turf) (1:46) STAKES. Purse \$150,000 Commonwealth Oaks presented by the Virginia Equine Alliance at Laurel Park FOR FILLIES THREE-YEAR-OLDS. By subscription of \$200 each which should accompany the nomination. \$650 to pass the entry box, \$650 additional to start, with \$150,000 Guaranteed, of which 60% to the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth, after payment of 1% to all owners of horses finishing 6th through last. Weight: 122 lbs. Non-winners of \$70,000 twice at one mile or over in 2016, allowed 2 lbs.; \$70,000 once at one mile or over in 2016, 4 lbs.; Non-winners of \$60,000 at one mile or over in 2016, 6 lbs. (Maiden and Claiming races not considered in estimating allowances). Trophy to the owner of the winner. Nominations closed Thursday September 15, 2016 with 29 nominations. (If deemed inadvisable by management to run this race on the Turf course, it will be run on the main track at One Mile and One Eighth) (Rail at 52 feet). (Cloudy 71)

MY IMPRESSION drifted out a bit entering the first turn, circled the first turn three wide, was in hand in the three path waiting for room around the far turn, was deftly taken to the two path in upper stretch, swept to the lead inside the eighth pole and eagerly drew away. NOBLE BEAUTY popped open her starting gate stall doors before the race, was angled to the inner rail approaching the first turn, remained along the rail through out and gained the place. PRICEDTOPERFECTION worked between horses around the far turn, angled to the four path in upper stretch, advanced nicely to mid stretch then flattened out. STELLA ROSE, three wide between horses leaving the far turn, floated to the five path in upper stretch, failed to menace and passed tired horses late. PRINCESS PRINCESS saved ground stalking the pace, drifted to the three path in upper stretch and gave way. IT'S THE TRUTH set the pace in the two path, drifted very wide in upper stretch and gave way. SHIAWASSEE, under urging five deep mid way on the far turn, advanced to mid stretch then gave way. SUPER ALLISON broke slowly and was not a factor. BROKEN BRIDLE stalked the pace, was four wide leaving the far turn and gave way. INVOLUNTARY chased the pace outside the pace setter and gave way.
