SEMAPHORE MAN with the pace three wide, put a head in front midway on the turn, headed in upper stretch, battled back in game fashion. JUNIOR COLLEGE just off the pace in the four path into the turn, ranged up, five wide bid, put a head in front in upper stretch, outfinished after a spirited stretch run. LOVANGO off the early pace, waited behind a wall of horses turning for home, again in upper stretch, roused when clear, not enough for the place late. EVENING REWARD lacked speed, moved closer late in the bend toward the inside, steadying restraint, lacked room three sixteenths out to the furlong marker, switched out, improved slightly. VICARINO with the pace four wide, continued four path through the turn, had little left for the stretch run. PIRATESONTHELAKE with the pace in the two path and between foes, faltered in the drive. SAALB narrowly set the pace along the inside, gave way.
