RUNAWAY GHOST was well-positioned stalking the early pace three wide, began to edge closer into the far turn, drew even in upper stretch and edged away late under steady handling. AMERICAN DUBAI set the pace in the clear racing just off the rail, was challenged by the aforementioned while drifting out just a bit leaving the turn, overtaken in upper stretch but fought on gamely. RAAGHEB settled off the pace, advanced two wide on the far turn, shifted in at the head of the lane to make a mild bid inside then evened out. PENDLETON rated off the leaders while kept a few paths off the rail, asked for more at the quarter pole going four to five wide into the stretch, failed to rally. DEPUTY'S ECHO was forwardly placed early along the rail, drifted out a bit in the stretch while running on evenly. HEREDITARY settled well off the leaders near the inside, came out three to four wide on the far turn then altered out six wide in the stretch and gained belatedly. AFRICAN FIGHTER switched outside a foe early, failed to threaten.
