The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of \$30,000 a llowed 2 lbs.; two races, 4 lbs.; a race at a mile or over, 6 lbs. (Maiden and claiming races not considered in allowances). A trophy will be presented to the winning owner. PRETENSION vied two wide early, continued three wide on the backside and far turn, battled it out with DISCO ON through the stretch, led late and just missed. DISCO ON raced close up inside, moved up between horses to contest the pace, dueled with PRETENSION past midstretch and dug in gamely on the rail to the finish. LIVE FOR TODAY raced four wide early, between rivals on the far turn, inside in the stretch and weakened. MISSISSIPPI DUEL stalked outside, raced three wide on the far turn and lacked a winning bid. TUG OF WAR raced in tight quarters between rivals on the clubhouse turn, continued between foes and weakened. COALITION raced three wide in tight quarters on the first turn, saved ground on the far turn and faded. THINK I'M HOOKED vied inside, dueled and tired.
