FOR TWO YEAR OLDS FOALED IN NEW YORK STATE AND APPROVED BY THE NEW YORK STATE-BRED REGISTRY.* No nomination fee. \$350 to pass the entry box and an additional \$400 to start. A supplemental nomination fee of \$1,500 in addition to the entry and starting fees will be accepted at any time prior to entries. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of \$35,000 allowed 2 lbs.; two races, 4lb s.; a race at a mile or over, 6 lbs. (Maiden and claiming races not considered in allowances). A trophy will be presented to the winning owner. Closed Saturday, November 24, 2012 with 16 Nominations. (Showery 46)

SMOOTH BERT raced four wide early, stalked outside, moved up inside of NOTACATBUTALLAMA approaching the stretch, rallied near the inside past midstretch and surged late for the win. NOTACATBUTALLAMA raced off the pace, advanced outside on the turn, closed willingly in the middle of the track, gained a short lead past the furlong marker and was outfinished late. JAMES JINGLE trailed the field, moved up on the turn, came three wide into the lane, rallied outside and was along for the show. IN HARM'S WAY broke in bumping a rival at the start, vied inside, shook free, opened up on the turn and gave way in the final furlong. GIANT FINISH was bumped at the start, chased between rivals and tired. REACHING OUT chased inside and tired. LAILA'S JAZZ chased three wide and faded. MEEKER AVENUE dueled two wide, chased three wide and faded.
