CHARGE NOW checked when caught in traffic entering the first turn, raced up close then swung out in the drive to be up for the place. H
TOWN BROWN tracked the speed three wide on the final turn then gave way in the drive. ROMPIN REID offered only a middle move.
PRIVATE RELATIONS hit the gate and lacked a necessary late response. RICO ROLANDO in good position, failed to menace. PART pressed
the pace between horses into the final turn, held a brief lead leaving the final turn and weakened in the drive. BIG ISLAND BOY unhurried
early, failed to respond. UNIKAT set the pace along the inside under pressure from PART into the final turn then tired midway.
