SERVICE FOR TEN , patiently handled well off the lead, took the turn two deep, swung to the four path when commencing his rally turning for home, gained the lead outside rivals near the sixteenth pole then drew clear under brisk, left hand urging. **FERSMILEY** bumped **ESCROW KID** when bearing out leaving the starting gate, saved ground, disputed the pace and finished willingly while no match for the winner. **ESCROW KID** , bumped and forced out by **FERSMILEY** leaving the starting gate, was well back early, hugged the inner rail around the turn and rallied. **RAINBOW HEIR** , four deep entering the turn, circled the bend, gained a three wide lead entering the stretch, remained in contention to midstretch then gave way late. **ACTION ANDY** , lightly bumped by **CONGRESSIONAL PAGE** soon after the start, was briefly steadied on the heels of **GUAM TYPHOON** near the five and a half furlongs pole, chased the pace and gave way entering the stretch. **CONGRESSIONAL PAGE** , checked and forced out a bit when bumped and pinched back soon after the break, was outrun. **GUAM TYPHOON** , angled in soon after the break, dueled two wide and faltered.
