Bay Filly, (Jan), by Pulpit - Apasionata Sonata by Affirmed. Trainer Salzman E. Timothy. Bred by Clover Leaf Farms II, Inc.(FL). BSHARPSONATA reserved racing along the inside, was steadied when caught in tight inside AMERICAN COUNTY on the turn, eased outside that rival for room, rallied to catch ROBBIE'S GAL inside the eighth pole and drew clear. GAME FACE rated off the pace, advanced on the turn to reach the attending position, then drifted out through the stretch and couldn't stay with the winner while wearing down ROBBIE'S GAL for the place. ROBBIE'S GAL set the pace under pressure outside AMERICAN COUNTY, drew clear from that rival on the turn while moving to the inside, made the pace to past the eighth pole, then weakened. INFORMED DECISION tired from good position. J Z WARRIOR rank under restraint in the early going, chased the pace three wide into the turn, then faltered. AMERICAN COUNTY pressed the pace inside ROBBIE'S GAL into the turn, then faded and was eased in the final eighth.
