ONLYFORYOU set the pace off the rail, repulsed a bid from HOUSE RULES on the far turn and opened a clear lead, then remained clear to the wire while drifting out late. HOUSE RULES stalked the pace three wide, made a run at the winner on the far turn but couldn't stay with that rival in the drive while saving the place. AURELIA'S BELLE stalked the pace off rail into the stretch but didn't do enough late. PENWITH failed to menace. STOPCHARGINGMARIA stalked the pace three wide and tired. LUNA SANTA was done early. ABOU broke slowly, then was rank on the first turn while rushing up to stalk the pace along the rail, remained in contention into the far turn, then faltered. HOLIDAY MAGIC was through after a half mile.
