FLY SO HIGH broke well then raced wide just off TAKE CHARGE PAULA coming out of the chute, was spotted well racing in range along outside, raced in aim at the quarter pole then four wide entering lane, gained equal terms with HEAVENHASMYNIKKI nearing the furlong marker, drove by to take command and finished clear, was pulled up and unsaddled in first turn then vanned off. TAKE CHARGE PAULA broke out and on top at the start and held narrow lead out of the chute, stalked just off the leader then lost couple positions, raced between with even response in the turn, angled out path upper stretch, kept under ride four wide and gained runner up spot. HEAVENHASMYNIKKI steadily advanced two to three wide and up to challenge ALTER MOON for the lead midway through the backstretch, dueled then held slim lead turning for home, fought back along inside when challenged by eventual winner, could not keep pace and gaveway in final sixteenth. SULTRY was unhurried and raced near the back, hustled up racing wide entering the lane then improved position under right handed encouragement. CACHE was away last then raced in range, waited along the inside near the quarter pole, gained clear path upper stretch but failed to move on. ALTER MOON dropped inside and gained the lead just after opening quarter, challenged midway through the backstretch and dueled along inside in the turn then faded in the lane. SUNNY SKIES raced off early pace then had no late response racing along outside in the lane. MISS MO MENTUM raced in back throughout.
