After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. GARDEN DISTRICT lost his footing at the start, vied for the lead inside and proved best under pressure. **RACHEL ALEXANDRA** within striking distance, advanced five wide on the turn, came in a bit on **CORLETT** inside the final furlong forcing that one in behind the leaders then finished willingly in a game effort. **SIMPLIFY** close up from the start, moved up three wide on the turn, challenged with a furlong to go, came out a bit near the sixteenth marker then held on gamely. **CORLETT** sluggish at the start, was reserved off the inside, advanced off the rail on the turn, angled out a bit for the drive, was blocked when carried in behind the leaders nearing the final sixteenth then lacked a late bid. **REND**A reserved early, made a good six wide move on the turn but could not sustain the bid. **CAMERON CRAZIES** vied for the lead off the inside and tired in the final furlong. **SONGTRESS** never far back along the inside, gave way. **YO ELEVEN** outrun early, raced four wide on the turn and could not threaten. **RUNAWAY HEART** forwardly placed three wide, moved four wide midway through the turn and faded. **SUPER PONI** was no factor while off the rail.
