After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. DECELERATOR stalked the pace while never far back, rallied into the stretch and dueled for the lead, exchanged bumps with WILD FOREST CAT and was all out to prevail in a long drive. WILD FOREST CAT dueled for the lead and prompted the pace, exchanged bumps with the winner and was outfinished to the wire. KINSOLVING was void of early speed, rallied into the stretch, failed to sustain the bid and ran evenly late. TIDAL POOL was pinched back soon after the start, ran evenly with no rally. PHONE MARYBE was in a good stalking position in mid pack, had no rally. SEND ROSE THECHECK was unhurried early, improved position but was no threat. BROWN EYED BABY dueled for lead and set the pace, was through after a half mile and dropped back. HENRY'S POSSE flashed brief speed before stopping. OUR TEKELA ROSE showed good early speed, faltered and faded.
