6 FURLONGS. (1:07²) STAKES. Purse \$100,000 Debutante S.FOR FILLIES, TWO YEARS OLD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$3,000 at time of entry. \$500 to pass the entry box; \$500 additional to start with \$100,000 guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 122 lbs. Non-winners of a race other than maiden or claiming, allowed 2 lbs.; a race other than claiming, 4 lbs. The maximum number of starters for the Debutante will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to highweights. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, June 15, 2016 with 29 nominations. (Cloudy 81)

PRETTY CITY DANCER hopped at the start and was back early, quickly kicked on into contention in the turn, shifted into the four path entering the lane then took over command in the stretch and drew away late under a brisk drive. ANNA'S BANDIT broke a bit slow at the start and trailed the field early on, swung into the six path in the turn, made a bid down the lane but flattened out late in the drive. COUNTRY CANDY stalked the pace early, angled off the rail in the turn and weakened late in the stretch run. TRICKY ONE tracked the early pace, took over and led briefly entering the lane and faltered late in the stretch drive. MAXIMUM EDGE was unhurried early, fanned into the seven path in the turn and moved up in the stretch. GRANDMA'S PRINCESS was shuffled back along the rail through the turn, came again in the stretch and improved position. SILVER THREADS broke awkwardly and was no threat. CHINA GROVE was through after a half. LIKE A HURRICANE had early speed then folded up. WHOLE SCOOP was done early.
