ROSE TO GOLD vied for the lead on the backstretch while racing three wide, was put into a strong drive and was inside on the far turn, dug in gamely in the stretch and proved best in the end. TOUCH MAGIC was well placed while racing five wide on the backstretch, rallied on the far turn then was two wide in the stretch, gained the lead in upper stretch but failed to sustained that bid in the end. SITTIN AT THE BAR was allowed to settle while racing four wide on the backstretch, dropped back entering the far turn, came again in the stretch and finished well but was no menace. MADAME CACTUS was stalking the pace while racing on the inside, swung out to be five wide in upper stretch then made a late gain and was no menace. SALAMERA vied for the lead while two wide, was in a long drive then weakened in the stretch drive. UNHEDGED vied for the lead while inside, was in tight on the far turn while still inside then weakened in the drive. FLORAL SKY was unhurried early then faltered. CAYLLANO stalked the pace while racing on the inside on the backstretch then failed to respond. CLOUDY IN SANDIEGO was unhurried early then was no factor. A claim of foul was lodged by the rider of UNHEDGED against the rider of SALAMERA for interference on the far turn. After reviewing the films, no action was taken.
