BENNY THE BULL, patiently handled off the rail, cruised up four wide entering the lane, responded to brisk hand pressure near the eighth pole, put a head in front a sixteenth out then edged clear late while having something left. TALENT SEARCH quickly opened up, set a brisk pace inside, repelled a mild challenge from HIGH FINANCE nearing the quarter pole, shook back clear in upper stretch, finished gamely but was no match late. MIRACULOUS MISS settled early, was lightly steadied nearing the turn, angled out approaching the three eighths pole, came five wide for the drive and closed willingly. WILL HE SHINE chased the pace three wide, made a mild run approaching the quarter pole, remained a solid presence to mid stretch then flattened out. SAINT ANDDAN, bumped at the break, recovered and settled in a good position along the rail, got through inside in upper stretch but failed to respond. HIGH FINANCE moved up three wide nearing the half mile marker to stalk the pace, lodged a mild bid nearing the lane, held well to the eighth pole then faded. HI TIME SCOTT saved ground while outrun into the turn, swung out wide for the drive but failed to menace. HOLLY TIME broke inward and bumped SAINT ANDDAN, moved closer two wide into the turn, chased the pace to the quarter pole then faltered in upper stretch.
