IMMORTAL EYES broke on top and cleared within the first few yards, angled in and set a rated pace in the two path, responded when knuckled on in upper stretch then powerfully moved away from the field under mild hand urging. **SATURDAY'S CHARM**, taken to rate while saving ground, angled out and advanced between rivals near the quarter pole, altered out five wide in upper stretch and finished well to gain the place. **SERVICE FOR TEN** eased back from between rivals entering the turn, angled in, was shut off when advancing in upper stretch, altered out in mid stretch to regroup, was guided back down towards the rail inside the sixteenth marker and finished strong. **ROYAL CURRIER** broke a step slow, was rushed up soon after and prompted the winner three wide, held well to mid stretch then faded. **IL VILLANO** stalked between rivals early, eased back a bit leaving the three eighths pole and angled four wide, made a menacing run approaching the stretch, failed to sustain and weakened in the final furlong. **BRIGAND** was hustled up to contention, had to be coaxd along the hold position racing towards the rail, entered the lane two wide, drifted in bothering **SERVICE FOR TEN** in upper stretch then gave way. **SAGE VALLEY** broke slowly, was put to a ride soon after and advanced to be in range after a quarter mile, gave hard chase four wide mid turn, failed to kick on and tired in the drive.
