7 FURLONGS. (1.20) STAKES. Purse \$250,000 DEL MAR DEBUTANTE S.(GRADE I) FOR FILLIES, TWO-YEAR-OLDS (FOALS OF 2004). By subscription of \$250 each, on or before June 2, 2006, the fee to accompany the nomination. For horses not nominated, supplementary nominations of \$10,000 each will close at the time of entry, Saturday, September 2, 2006. All horses shall pay \$500 to pass the entry box and \$2,000 additional to start, with \$250,000 Guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. Weight 123 lbs.; Non-winners of \$50,000 twice allowed 2 lbs.; of such a race, 4 lbs.; of \$25,000 other than maiden or claiming, 6 lbs.; of a race other than claiming, 8 lbs. A trophy will be presented to the owner of the winner. Nominations closed Friday, June 2, 2006 with 175 nominations. Supplemental Nominations closed Saturday, September 2, 2006 with 2.

POINT ASHLEY stalked the pace off the rail then outside a rival leaving the turn, bid three deep a quarter mile out, gained the lead into the stretch, drifted out a bit then inward some but won clear under urging. UNTOUCHED TALENT chased a bit off the rail, came out into the stretch and surged between foes late for the place. SHE'S INCLUDED chased outside a rival on the backstretch and turn, continued off the rail in the stretch and was edged late for second but held the show. OUTOFTHEPAST broke out a bit, dropped back off the rail, came a bit wide into the stretch and narrowly missed a minor award. JUMP ON IN stalked the pace a bit off the rail, bid between foes leaving the turn and weakened in the final furlong. FILLIE BY THE BAY settled a bit off the rail chasing the pace, angled in on the turn and did not rally. NUSHKA BABEE broke a bit slowly, settled just off the inside to the stretch and lacked a further response. MISTICAL PLAN sped to the early lead, set the pace inside, offered little resistance when challenged leaving the turn and gave way in the stretch.
