1½ MILES. (Inner Turf) (1.453) STAKES. Purse \$500,000 TVG DIANA S. (GRADE I) INNER TURF FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD. By subscription of \$500 each which should accompany the nomination; \$3,500 to pass the entry box and an additional \$4,000 to start. For horses not originally nominated, a supplemental payment of \$12,000 along with the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remain ing finishers. Three year olds, 118 lbs.; Older, 123 lbs. Non-winners of a Grade I at a mile or over twice in 2013-14 allowed 2 lbs.; such race in 2013-14 allowed 4 lbs.; a Grade II twice at a mile or over in 2013-14 allowed 6 lbs.; a Grade II or two Grade III races at a mile or over in 2013-14 allowed 8lbs. Trophies will be presented to the winning owner, trainer and jockey. The New York Racing Association reserves the right to transfer this race to the Main Track. In the event that this race is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee. Closed Saturday, July 5, 2014 with 22 Nominations. (Cloudy 78)

SOMALI LEMONADE was rated on the inside, drafted behind the leaders while patiently ridden on the far turn, came out into the stretch, rallied on the outside, closed well to get the lead inside the sixteenth-pole and prevailed under strong urging. STEPHANIE'S KITTEN jostled with STRATHNAVER early, raced in the two path on the first turn, settled off the pace, went two then three wide on the far turn, was roused near the five-sixteenths, came four wide into the stretch and finished fast to just miss. DISCREET MARQ contested the pace on the inside while in hand, came under a drive in upper stretch, inched clear into the final furlong, led into the final sixteenth but was caught while able to get the show. ABACO dropped back after the start, raced in the two path on the first turn, lagged at the rear, went three then four wide on the far turn, was asked near the five-sixteenths, came five wide into the stretch, drifted out under a left-handed whip in the vicinity of the furlong marker, was switched to a right-handed whip and finished with good energy. SOLID APPEAL was very rank off heels on the initial straightaway then taken up, raced on the inside while under restraint, saved ground through the far turn, came under a drive in upper stretch and finished willingly along the hedge. STRATHNAVER (GB) jostled with rivals on both sides early, went three wide on the first turn, settled on the outside, raced three wide on the far turn, was asked outside the quarter-pole, chased into the final furlong and lacked the needed kick. CAROLINE THOMAS bobbled behind horses early, raced in the three path on the first turn, lagged near the back, negotiated the second turn in the two path, came three wide into the stretch and gained some but failed to seriously threaten. ALTERITE (FR) pulled while eager early, moved up while three wide on the first turn, contested the pace on the outside, came under a drive in upper stretch, dropped back near the furlong marker and weakened. EMOLLIENT jostled with STRATHNAVER early while rank between horses then was taken up, was taken up again while still rank late on the first turn then reserved towards the back, saved ground while still under some restraint on the far turn, was let out near the quarter-pole and failed to threaten. TANNERY (IRE) was hard held while rank early, raced in the two path on the first turn, was wrestled off the pace then rated, came under urging between horses late on the backstretch, chased in the two path on the far turn and tired. (Rail at Hedge)
