(GRADE III) FOR FILLIES AND MARES THREE YEARS OLD AND UPWARD.* By subscription of \$200 each which shall accompany the nomination; \$750 to enter and \$1,000 to start. \$200,000 Guaranteed (*includes \$50,000 from Breeders' Cup fund for cup nominees only). The host association's money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Breeders' Cup monies not awarded reverts back to the fund. Weight: Three year olds 118 lbs. Older 123 lbs. Non-Winners of \$90,000 at a mile or over on the turf in 2010 allowed 2 lbs. \$60,000 at a mile or over on the turf in 2010, 4 lbs. \$45,000 at a mile or over on the turf in 2010, 6 lbs. (Maiden, claiming and starter races not considered in estimating allowances). The winning owner, trainer and jockey to receive a trophy from Breeders' Cup Limited. Closed Saturday, July 3, 2010 with 36 Nominations. (If deemed inadvisable by management not to run this race over the turf course, it will be run on the main track at One Mile and One Quarter). (Clear 90)

TREAT GENTLY (GB) moved closer outside rivals in the run to the far turn, loomed boldly with a furlong remaining then drove clear late. A SHE'S ADORABLE, well placed close to the pace, collared the pacesetter in midstretch then was not quite good enough for the winner. AINAMAA moved to the inside when early to set the pace and fought it out gamely to the end. GOZZIP GIRL moved up along the inside leaving the backstretch, drifted into the gap at the chute in midstretch and continued willingly. LIBERALLY (IRE) moved closer around the far turn then lacked the needed closing response. PROUD LISA was unhurried early then failed to threaten. KATARA lacked a rally. TRENDA was forwardly placed near the inside to the far turn then weakened. WINTER'S CIRCLE tired from her early effort and was being eased up in deep stretch. RCUANDRY saved ground to little avail then tired and was being eased up in deep stretch.
