For horses not originally nominated, a supplemental nomination payment of \$1,500 in addition to the entry and starting fees can be made at any time prior to the publication of weights. The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. TOMMY MACHO attended the pace four then three wide dangling what appeared to be a strap from an assistant starter off the near side, took over narrowly three furlongs from home, spun four wide into upper stretch roused for the drive, drew clear kept busy to the wire, the strap remaining onboard until the gallop out. MADEFROMLUCKY tracked the pace three then two wide coming under coaxing half a mile from home taking to the inside briefly until shifted back to the two path five-sixteenths from home, continued just off the inside into upper stretch, offered up a belated mild bid to secure the place honors. OCEAN KNIGHT in hand on the pace three then two wide, got headed three furlongs from home and came under coaxing in response, swung three wide at the quarter pole, dug in under a drive and kept on through to the wire to garner the show honors. SMART TRANSITION three wide through the first turn, settled four wide just off the pace, came under coaxing midway on the far turn, angled five wide into upper stretch, weakened late on. FIRST SPARK three wide near the rear, came under urging just off the inside midway on the far turn, angled six wide into upper stretch and weakened in the drive. TOTAL JOINT leapt up at the start conceding three to four lengths to the front, saved ground at the rear, came under coaxing seven-sixteenths from home, angled six wide into upper stretch and offered no response. MADE IN DETROIT just off the pace three wide between foes, came under a ride at the three-eighths, swung three wide into upper stretch and faltered.
