1½ MILES. (Turf) (1.443) STAKES. Purse \$300,000 *DEL MAR DERBY (GRADE II) FOR THREE-YEAR-OLDS*. By subscription of \$300 each, which shall accompany the nomination, or by supplementary nomination of \$3,000 each by closing time of entries, closed with 1. \$1,000 to pass the entry box and \$3,500 additional to start, with \$300,000 Guaranteed, of which \$180,000 to first, \$60,000 to second, \$36,000 to third, \$18,000 to fourth and \$6,000 to fifth. Weight 122 lbs. First preference will be given to graded or group stakes winners. Second preference will be given to horses which have finished second or third in graded or group stakes. Total non-claiming purse earnings will determine the order of preference for horses of equal status. Entry fees will be refunded to all horses which fail to draw into this race. A trophy will be presented to the owner of the winner. Nominations closed Thursday, August 26, 2010 with 11. (Clear 73)

TWIRLING CANDY sped to the early lead and angled in, set the pace inside, came out leaving the first turn then ducked out sharply early on the backstretch, was angled in under a tight left rein, responded when challenged leaving the backstretch and on the second turn, inched away again into the stretch, was mildly hand ridden for a few strides to open up again and won clear without further encouragement. **ROYAL F J** chased outside a rival, came out leaving the second turn and four wide into the stretch and held third three deep on the line. **FANTASTIC PICK (GB)** four wide in the chute, angled in and saved ground chasing the pace, cut the corner into the stretch, continued along the rail and was outfinished for a minor award. **KID EDWARD (IRE)** chased inside then came out leaving the first turn, went outside a rival on the backstretch and second turn, angled three deep into the stretch and could not summon the necessary late response. **SUMMER MOVIE** stalked off the rail, inched up into the backstretch, was forced out sharply and steadied outside the winner early on the backstretch, bid again alongside that one into the second turn, dropped back between foes in the stretch and weakened. The stewards conducted an inquiry into the incident on the backstretch but made no change when they ruled it did not alter the original order of finish.
