some into the stretch, inched away in upper stretch and kicked clear under a crack of the whip and some hand urging then a long hold late. SWIPE stalked a bit off the rail then inside, came out leaving the turn and into the stretch and was clearly second best. BLAMEITONTHELAW close up stalking the pace between rivals on the backstretch, bid three deep between foes into the turn, angled in some into the stretch and held third. ROCKIN BAYOU hopped in the air and threw his head in an awkward start, stalked three deep, bid four wide into and on the turn and into the stretch and weakened. ANNIE'S CANDY sped to the early lead, set the pace inside, dueled along the rail on the turn, came out a bit past midstretch and had little left in the final furlong. ARCHAEO broke a bit slowly, chased just off the rail then inside on the turn and gave way.
