MAGICAL FANTASY angled in and saved ground off the pace, moved up inside on the second turn, waited briefly then got through inside into the stretch, split horses in midstretch to gain the lead past the eighth pole and won clear under urging. BEL AIR SIZZLE unhurried off the rail early, went outside on the second turn, came five wide into the stretch and gained the place late. LETHAL HEAT pulled her way between horses then stalked a bit off the rail, bid between foes to gain the advantage into the second turn, fought back between rivals on that turn and into the stretch, continued off the rail in midstretch and just held third. SATAN'S CIRCUS pulled her way along toward the inside then stalked along the rail, went between horses on the second turn and into the stretch, split rivals in the drive and was edged for the show. STORM MESA stalked inside then a bit off the rail, bid three deep into and on the second turn, battled outside LETHAL HEAT to midstretch and weakened in the final furlong. MISSIT (IRE) settled off the rail, was in a bit tight into the second turn, swung four wide into the stretch and lacked the needed rally. MISTY OCEAN pulled her way to the early lead and angled in, set the pace inside, fought back into and on the second turn and weakened in the stretch. OCEANE MUSIC (FR) saved ground stalking the pace, waited a bit leaving the second turn, came out for room into the stretch and weakened, then did not return to be unsaddled and was vanned off. MILLION DOLLAR RUN wide in the chute, angled in and chased outside a rival, continued three deep leaving the backstretch and four wide on the second turn and into the stretch and lacked a further response. GINGER POP pulled early, stalked outside a rival then three deep between foes on the second turn and into the stretch and weakened.
