By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry. \$500 to pass the entry box; \$500 additional to start with \$100,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of a Graded stakes at a mile or over allowed 2 lbs.; \$60,000 at a mile or over, 4 lbs.; three races other than maiden or claiming, 6 lbs. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. Closed Saturday, May 16, 2009 with 25 nominations. (Clear 81)

Gray or Roan Filly, (Feb), by Tapit - Don'ttellmichelle by Regal Classic. Trainer Asmussen M. Steven. Bred by Springland Farm(KY).

HIGHTAP advanced from between horses down the backstretch, worked her away to the outside and ranged up to engage the leaders four wide, wore down LUSTER and edged clear late. LUSTER stalked the pace between horses, launched her bid three wide, poked her head in front nearing the furlong marker but was unable to resist the winner late. PERFECT FOR YOU tucked in under a snug hold to save ground, swung five wide leaving the turn, and was along in time to earn the show. SLIDES CHOICE pressed the pace between horses early, then along the inside through the turn, but weakened entering the stretch and gave way. LADY'S LAUGHTER vied for the lead three wide, then from between horses through the turn, disputed the issue to the final furlong and faded. DAVE'S REVENGE broke slowly and was unhurried into stride, made a belated gain from between horses but failed to threaten. WALLOON settled saving ground, altered course to avoid her stricken rival after a half, dropped back to the inside through the turn, angled out entering the stretch but lacked a response when called upon. TWEETER was hung wide and showed little. AFFIRMED TRUTH set the pressured pace along the inside, went wrong after a half, was pulled up sharply and vanned off.
