1 $\frac{1}{4}$ MILES. (1.404) STAKES. Purse \$100,000 *HILLIARD LYONS DOUBLED*OGDARE S. (GRADE III) FOR FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry (includes entry and starting fees). \$500 to enter and an additional \$500 to start, with \$100,000 guaranteed, of which \$60,000 to the owner of the winner, \$20,000 to second, \$10,000 to third, \$5,000 to fourth, \$3,000 to fifth and \$2,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of a Grade I at a mile or over since October 4, allowed 3 lbs.; \$60,000 twice at a mile or over since July 4, 5 lbs. The maximum number of starters for the Hilliard Lyons Doubledogdare will be limited to fourteen. In the event that more than fourteen fillies or mares pass the entry box, the fourteen starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest 2013-2014 earnings. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. Closed Wednesday, April 2, 2014 with 44 nominations. (Cloudy 67)

SISTERLY LOVE was away in good order, disputed the pace with the odds on favorite EMOLLIENT every step, fought valiantly and was fully extended. MOMENT IN DIXIE was unhurried into stride off of the inside, was put to pressure with five-sixteenths to run, wheeled out six wide entering the stretch, finished with a surge and was getting to the winner with every stride. EMOLLIENT contested the pace three wide, gained a narrow edge entering the stretch, but weakened slightly between rivals and settled for the show. STRATHNAVER (GB) was allowed to settle, came four wide to make her bid, loomed a danger but was unable to bridge the gap. SOLID APPEAL settled between horses, took closer order leaving the second turn, but toiled through the drive and failed to make serious headway. IRE was allowed to settle, tipped out five wide leaving the second turn, offered a mild bid but flattened during the drive. NOBLE CHARLOTTE broke a step slow, was unhurried into stride, came four wide and finished with belated improvement between rivals. GOLD MEDAL DANCER was close up four wide, but came up empty between horses leaving the second turn and gave way. SISTERHOOD was forwardly placed between horses through the second turn and tired. PEARL TURN attended the pace along the inside for six furlongs and stopped.
