APPLE BETTY (IRE) tracked in hand, tucked in to save ground on the second turn, got through leaving the final turn, quickly spurted clear and maintained a safe advantage. PROMOTIONAL was allowed to settle toward the inside, advanced between runners on the final turn, came four wide into the stretch, angled in for the final furlong and kicked on well to earn the place. LOTTIE settled between horses, took closer order on the final turn, shifted out entering the stretch, churned on but settled for the minor award. GRATEFUL was allowed to settle, ranged into striking distance five wide, but weakened between rivals in the drive and faded. COCO CHANNEL bobbled and was bumped early, settled saving ground in mid pack, but went evenly through the drive. PLACE DES VOSGES was allowed to settle four wide, came six wide but lacked a response when called upon. DARING DUCHESS bumped with COCO CHANNEL early, was rank to place in traffic, shifted out and pulled to contention five wide, leveled into stride on the second turn, was collared between rivals on the final turn, was caught in tight and steadied near the furlong marker and came up empty thereafter. POLAR VORTEX lagged well back and passed only the tiring ones. DADDY'S BOO opened clear, set the pace off of the inside, was collared between horses entering the stretch and gave way readily once headed. BOOTSY'S GIRL was forwardly placed along the inside to the final turn and stopped.
