CLOSE IT OUT off a step slow, trailed for three furlongs, began to pick up foes midway on the turn, swung out widest for the drive and closed with a flourish to be in time down the middle of the strip. BAHAMIAN SQUALL in the second flight early while outside, moved up closer and challenged four wide turning for home, took over, shook clear, could not contain the winner in the waning strides. BULL DOZER lacked speed, raced four out to five wide in the turn, modest interest in the drive to finish best of the rest. GOLDEN MYSTERY back off the pace for a half in the two path, improved position through traffic. BLACK DIAMOND CAT lacked speed off the inside, angled out for the drive, steered back in a bit nearing the furlong marker, lacked clear room in tight quarters soon after, managed some gain the final sixteenth when clear. DUAL EXHAUZT broke alertly, forced the issue three wide for a half and then weakened in the drive. CAJUN BREEZE within contact of the leaders for a half in the three path, came up empty for the drive. OFF THE JAK vied up front until a quarter remained while between foes and gave way. ABDEL'S GHOST set or forced the pace along the inside for just under four furlongs, was tiring when forced to steady in tight quarters turning for home, continued to back up. NO LIFT SHIFT was finished early, far back.
