(GRADE III) FOR THREE-YEAR-OLDS AND UPWARD.* By subscription of \$150 each which shall accompany the nomination and an additional \$1,500 when making entry. The purse to be divided: 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth, 1% to sixth, 1% to seventh, 1% to eighth. Weight: Three-Year-Olds 122 lbs.; Older 126 lbs. Non-winner of a Sweepstakes of \$60,000 three times at a mile or over in 2012, allowed 3 lbs.; Of a Sweepstakes of \$60,000 twice at a mile or over in 2012, allowed 5 lbs.; Of a Sweepstakes of \$60,000 once at a mile or over in 2012, allowed 7 lbs. (No Canadian Bred Allowance.) Final entries to be made through the entry box at the closing time then in effect for overnight events. A supplemental nomination may be made no later than the time of final entry, by a non-refundable fee of \$3,000, which includes the entry fee. (Closed with 18 Nominations) \*Plus up to \$19,500 Ontario Sired/Ontario Bred Breeder Awards. (Showery 18)

JAMES STREET settled off the pace, chased four-wide on the far turn and finished willingly. ALPHA BETTOR, rated off the pace, was in range on the far turn and finished under a determined drive. VERTIFORMER stalked the pace, chased hard late turn but evened out in the stretch.

MOBILIZER, jostled at the start, settled in midpack, chased four-wide late turn then flattened out with a furlong to run.
