By subscription of \$75 each, which should accompany the nomination. A supplemental nomination fee of \$750 may be made by time of entry; \$350 to pass the entry box; \$400 to start, with \$75,000 added. All entrants will be required to pay entry and starting fees. The added money and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equal ly among remaining finishers. 122 lbs. Non-winners of \$30,000 allowed 2 lbs.; two races, 4 lbs.; a race at a mile or over, 6 lbs. (Maiden and claiming races not considered in allowances). A trophy will be presented to the winning owner. Closed Saturday, N ovember 17, 2007 with 17 Nominations and 1 Supplemental Nominee. (Snowing 29)
