By subscription of \$100 each if made on or before Thursday, September 20, 2012 Closed with 23. All horses to pay \$500 to pass the entry box and \$1,000 to start with \$100,000 guaranteed, of which \$60,000 to first, \$20,000 to second, \$12,000 to third, \$6,000 to fourth, \$2,000 to fifth. Three-year-olds: 120 lbs. Older: 123 lbs. Non-winners of a Graded Stakes since March 28, allowed 3 lbs. Non-winners of a Graded Stakes since September 28, 2011, 5 lbs. (Clear 90)

UNBRIDLED'S NOTE pulled his way along to stalk the pace outside, came three deep into the stretch, rallied under some left handed urging to gain the lead in deep stretch and proved best. CHOSEN MIRACLE sped to the early lead and set the pace a bit off the rail, dueled inside leaving the hill, came out into the stretch, inched away again nearing midstretch, was between foes in deep stretch and held second. MENSA HEAT chased between foes then outside, swung five wide into the stretch and gained the show late. COMMA TO THE TOP stalked between foes then off the rail, angled to the inside in the stretch and was edged for third. TALE OF A CHAMPION chased between horses then a bit off the rail, angled in entering the stretch and lacked the needed late kick. BOXEUR DES RUES a bit awkwardly into stride and squeezed between foes early, settled off the rail then three deep leaving the hill, came six wide into the stretch and found his best stride late. CANULETMEDOWNEASY bobbled at the start, tugged early, stalked outside, bid alongside a rival leaving the hill, was floated out some into the stretch and weakened. OCTANE chased off the rail, came out four wide into the stretch and could not offer the necessary late kick. RED SUN settled off the rail chasing the pace, angled in some leaving the hill and did not rally. SHRUG settled just off the inside, came out leaving the hill and into the stretch and was not a threat. CALIMONCO stalked the pace inside, dropped back along the rail then steadied leaving the hill and weakened. CRIMSON GIANT allowed to settle off the pace inside, saved ground on the hill, came out into the stretch and failed to menace. Rail on hill at zero.
