ARAGORN (IRE) chased a bit off the rail, came three deep into the stretch, rallied to the front nearing midstretch and drew clear while drifting out under right handed pressure. SWEET RETURN (GB) sped to the early lead set the pace inside, fought back into the stretch, was no match for the winner but gamely held second. SILENT NAME (JPN) had the rider lose the whip in the chute, stalked off the rail, bid outside the runner-up on the second turn and between horses into the stretch and edged rivals for third. FORTY NINERS SON chased inside then outside a rival, split horses on the second turn, came out and brushed a foe in midstretch and went between horses at the wire. QUASIMODO chased inside then off the rail, went three deep on the second turn then outside a foe, was brushed in midstretch and lacked the needed rally. HENDRIX angled in and saved ground off the pace, came out into the stretch and could not offer the necessary late kick. FAST AND FURIOUS (FR) angled in and settled inside then a bit off the rail, came out in the stretch and was not a threat. Following a stewards' inquiry, FORTY NINERS SON was disqualified and placed fifth for interference in the stretch. NEW COURSE RECORD.
