ZAKAROFF was settled to the half, advanced inside on the second turn, eased out for room once in the stretch, rallied determinedly in the drive and was up in time. ANN ARBOR EDDIE stalked the pace to the second turn, dueled from the rail to the stretch, inched away to mid stretch then lugged out despite right handed whipping, caused TRIBAL STORM to take up and was caught late. MORE POWER TO HIM was rank between rivals and hard to place to the backstretch, took back and trailed to the second turn, got fanned four wide to the stretch then was closing steadily in the late stages. TRIBAL STORM was on the pace to the second turn, raced two wide to the stretch, got outkicked by ANN ARBOR EDDIE to mid stretch but kept on then was cut off when that one lugged out into his path, took up and lost the show late. COLONEL SAMSEN was outrun while four wide to the second turn, rallied four deep to the stretch but flattened out in the drive. KONA DREAMS stalked the pace to the half, moved up three wide to duel for the lead on the second turn but tired in the stretch. SHEER FLATTERY settled early, tried to rally two then three wide on the second turn but gave way in the drive. The stewards conducted an inquiry into the stretch run involving ANN ARBOR EDDIE and TRIBAL STORM and disqualified ANN ARBOR EDDIE from second to fourth for interference. It was a unanimous decision.
