1 1/2 MILE. (Turf) (2:31²) STAKES, Purse \$250,000 Dixiana Elkhorn S. (Grade II) FOR FOUR YEAR OLDS AND UPWARD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$7,500 at time of entry (includes entry and starting fees). \$1,250 to enter and an additional \$1,250 to start, with \$250,000 guaranteed, of which \$150,000 to the owner of the winner, \$50,000 to second, \$25,000 to third, \$12,500 to fourth, \$7,500 to fifth and \$5,000 to be divided equally among sixth through last. Weight: 123 lbs. Non-winners of Grade I stakes over ten furlongs on the turf since October 6, allowed 3 lbs.; a Grade I or II stakes over ten furlongs since July 4, 5 lbs. The maximum number of starters for the Dixiana Elkhorn will be limited to fourteen with two also eligibles. In the event that more than fourteen pass the entry box, the fourteen starters will be determined at that time with preference give to graded stakes winners (in order I-II-III), then highest turf earnings in 2017-2018. Starters to be named through the entry box by the usual time of closing. Keeneland will present a trophy cup to the winning owner. Closed Wednesday, April 4, 2018 with 41 nominations. In the event that this race is taken off the turf it will be contested at One Mile and Five-Eighths on the main track. (Clear 65)

ONE GO ALL GO set the pace from the outset, angled off the rail into the lane, was under a long drive down the lane, repelled bids while between horses late and was driven clear in the final stages. OSCAR NOMINATED stalked the pace early on, made a bid three wide near the quarter pole, continued the bid down the lane while four wide, was just up for place but did not have enough to get to the winner in the final stages. ITSINTHEPOST (FR) tracked the pace early, shifted into the three path into the lane while making a strong bid, continued the bid down the lane while three wide but hung late and lost place at the wire. CALL PROVISION was well placed early on, angled off the rail into the lane, altered closer to the rail down the lane while making a bid but flattened out late in the drive. DANISH DYNIFORMER was unhurried early on, shifted into the three path entering the lane with a belated gain in the stretch run. CANESSAR (FR) was back early on, shifted into the four path into the lane with a mild gain down the lane. BIG BEND chased the pace early, fanned into the five path in the final turn and leveled out in the stretch run. SOME IN TIEME (BRZ) was back early on, shifted into the four path entering the lane while making a bid but weakened late in the stretch drive. HUNTER O'RILEY was never a threat. HAYABUSA ONE (FR) was through after a half. BULLARDS ALLEY went wrong early in the first turn, was pulled up and vanned off.
