SWEET REPENT chased the pace, rallied to catch JESSICA IS BACK entering the stretch, vied with that rival to inside the eighth pole, then drew clear. JESSICA IS BACK set the pace along the rail, responded when challenged by SWEET REPENT entering the stretch but couldn't stay with that rival in the final eighth while clearly second best. EVEN ROAD outrun while saving ground into the far turn, angled out for the drive and couldn't keep pace with the top ones while gaining the show. SWEETSOUTHERNQUEEN stalked the pace to nearing the stretch, then tired. CAT CAN DO failed to menace. BOB'S JAWBREAKER was no factor while racing four wide. ONE PROUD LADY tracked the pace three wide to midway of the far turn, then faltered. ANNABILL rated off the pace, faded leaving the far turn. MANY KISSES showed little.
