1½ MILES. (1.471) STAKES. Purse \$150,000 FALLS CITY H. (GRADE II) FOR FILLIES AND MARES, THREE-YEARS-OLD AND UPWARD. By subscription of \$150 or by supplementary nomination of \$4,500 each by 12:00 noon (EST) Thursday, November 21, 2013. \$750 to pass the entry box; \$750 additional to start, with \$150,000 added. After pay ment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights to be announced Friday, November 22, 2013. The maximum number of starters for the Falls City Handicap will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box preference will be given to highweights, with consideration to the scale of weights for age. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box by the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner. Closed Wednesday, November 13, 2013 with 17 nominations. (Clear 27)

WINE PRINCESS close up while three wide and reserved, challenged when ready approaching the stretch then drew clear under steady handling. DON'T TELL SOPHIA outrun early three wide, angled out, made a bold five wide middle move, reached closest to the winner in midstretch but lacked a late bid. FLASHY AMERICAN within striking distance off the rail, was patiently handled around the second turn, angled out a bit for the drive but lacked a rally. MY OPTION within striking distance three wide, made a four wide move to a forward position on the second turn but lacked a further bid. MAGIC HOUR set the pace off the inside, held on well to the final furlong and tired. ICE CREAM SILENCE close up along the inside, gave way in the final quarter. MOLLY MORGAN stumbled at the start, was in hand early then never threatened. OWL MOON lost her footing a bit at the start and was through early.
