After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weights to be announced Friday, November 19, 2010. Starters to be named through the entry box by the usual time of closing. Trophy to winning owner. Closed Wednesday, November 10, 2010 with 15 nominations. (Rainy 55)

DUNDALK DUST reserved for a half, moved up three wide after six furlongs, angled out for the drive and closed well to be clear. HIGH QUAIL sprinted clear and angled in, set the pace along the inside, increased her lead into the stretch, could not cope with the winner late but held on for the place. STRIKING DANCER stumbled at the start, was reserved three wide, maintained her position to the stretch and lacked a late bid. RAVI'S SONG within striking distance four wide, advanced four wide after six furlongs, reached a forward position with a furlong to go but weakened. THIRD DAWN close up off he inside, moved out a path for the second turn, held on well to the final quarter and gave way. DISTINCTIVE DIXIE closest to the pace off the inside, stayed on well to the stretch and faded.
