(GRADE III) FILLIES, THREE YEAR OLDS.* By subscription of \$100 each, which shall accompany the nomination, original nominators paying \$2,500 to pass the entry box and \$2,500 additional to start. Supplementary nominations may be made by the closing time of entries at a fee of \$7,500 which qualifies to start, with \$400,000 Guaranteed of which 60% to the Owner of the winner plus 100 Kentucky Oaks points, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEI GHTS: 121 lbs. Non-winners of a sweepstakes allowed 4 lbs. In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Certain finishing positions in this race will earn points to qualify for the 2013 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. ROSE TO GOLD broke alertly, took control, set all the pace toward the inside, expanded advantage on her own courage into the lane, kept to task with an intermittent but firm right handed stick to the wire. MANUKA HONEY pressed the winner from the outside, moved briefly closer into the far turn, could not maintain contact in the drive, drifted out a bit with a furlong to run, lasted for the place. MARATHON LADY stalked the pace, moved closest on the outside turning for home, also had little for the winner to the wire, flattened out the final furlong and did not have not enough for the place. LIBERTY GIRL back off the pace while racing outside, improved slightly while never a serious threat.

INSPIRED EXCHANGE fell far back after the start, moved out, made little impact in the drive. HUNG THE MOON fractious in unseating rider in the post parade, broke in good order, raced in the second group toward the inside, retreated in the drive. LEGAL MIND was finished early.
