1 MILE. (Inner Turf) (1:33) STAKES. Purse \$150,000 Forbidden Apple S. (Grade III) INNER TURF FOR FOUR YEAR OLDS AND UPWARD. By subscription of \$150 each which should accompany the nomination. \$750 to pass the entry box and an additional \$750 to start. For horses not originally nominated, a supplemental payment of \$1,500 (along with the entry and starting fees) may be made at any time prior to the closing of entries. The purse to be divided 55% to the owner of the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% divided equally amongst the remaining finishers. Weight, 124 lbs. Non-winners of two Sweepstakes at a mile or over in 2018-19 allowed 2 lbs.; of such a race since September 1, 2018 or two races other than maiden, claiming, starter or State-Bred allowance at a mile or over in 2019 allowed 4 lbs.; of such a race in 2019 allowed 6 lbs. A trophy will be presented to the winning owner. The New York Racing Association reserves the right to transfer this race to the Main Track. In the event that this race is taken off the turf it may be subject to downgrading upon review by the Graded Stakes Committee. Closed Saturday, June 29, 2019 with 27 Nominations. (Rail at 9 feet). (Clear 80)

MR HAVERCAMP away without apparent mishap, sat within striking distance in the three path on each bend, crept up as three-quarters was being completed, got set down stepping onto the head of the stretch, challenged in earnest a sixteenth down the road, grabbed away the advantage, finished with good determination to preserve the decision. HEMBREE took up position in the two path after the field had been released, got let out a notch after departing the backstretch, got asked for more being maneuvered to the outside for the drive, eventually being fanned out into the six path to become the widest of all, closed in with good energy down the center of the course to garner the place. QURBAAN tracked the front runners towards the inside route, was switched over to a light hand ride by the three-eighths pole to keep interest, got sent outward after entering the stretch, settling in right around path five, came home willingly to secure the show. MADE YOU LOOK pursued the pace from the two path, going about it from between rivals for much of the journey leading up to the half mile pole, moved out four wide during the early stages of the stretch run, made no headway in the last eighth. MARCH TO THE ARCH sat reserved in the two path, tipped a bit during the stretch run, split rivals late narrowing in, just missed out on the last major check. DOCTOR MOUNTY unhurried taking the two path, got sent into path five during the initial portion of the stretch, rallied midly but without impact. OFFERING PLAN pinched at the start, took the inside route for until the end of the bend, failed to fire after getting spotted in the two path. VOODOO SONG stalked the pace from path two, got roused spinning onto the top of the lane, faltered. GIDU (IRE) off to a sharp beginning, kicked away to an open lead, was coaxed along carving out the pace from along the inside route, shadowed by VOODOO SONG from the outside, felt an uptick in pressure as the third fraction was being finalized, gave in at the furlong grounds, then steadily backed away. FIRST PREMIO got set up in the pocket in short order, was kept in reserve for nearly six furlongs cut the corner into the lane, idled behind VOODOO SONG, having some clearance along the rail corridor, but not of the optimal sort, attempted to tip to the outside of the aforementioned rival coming up to the sixteenth marker, only to have that opponent drift a bit wider too, becoming once again directly in front, faded away the rest of the trip to the wire, lightly ridden out.
