OLYMPICO (FR) tossed his head at the start getting away last and conceding two to three lengths to the front, saved ground through the opening bend before settling three wide at the tail of the field, remained patiently handled two to three wide through the far turn, got set down angled three to four wide into upper stretch, rallied to issue a challenge a furlong from home, rolled by the top pair a sixteenth out and edged clear to the finish kept to task. DR. EDGAR stumbled at the start and broke forwardly placed despite it, established the front shortly after and showed the way narrowly just off the inside through the first turn and into the backstretch, widened to a safe advantage tucking to the inside five furlongs from home, settled into a comfortable rhythm into the far turn, came under coaxing at the five-sixteenths as a pair of rivals advanced outside, spun just off the inside for home, dug in and was headed with three-sixteenths to go, knocked heads with ROBERT BRUCE through to the sixteenth marker when overtaken as a pair by the top one, then fought on to secure the place honors. CULLUM ROAD saved ground settled in mid pack, came under coaxing three furlongs from home, angled five wide into upper stretch, kept on through to the finish and just missed for the place honors. CHANNEL CAT two to three wide in pursuit in range of the leader, came under coaxing at the three-eighths, angled four wide into upper stretch, weakened in the late stages. ROBERT BRUCE (CHI) bobbled at the break, led briefly before conceding the front to DR. EDGAR, tracked the pace along the inside before taking to the two path down the backstretch, came under coaxing three furlongs from home, spun three wide into upper stretch, took over narrow command three-sixteenths from home, dueled with DR.EDGAR through to the sixteenth marker before succumbing near that station, then weakened in the late going. DOCTOR MOUNTY just off the inside near the rear, came under coaxing at the three-eighths, continued just off the inside into upper stretch and offered no response. MARAUD three wide through the first turn, chased three then two wide from mid pack, came under coaxing five-sixteenths from home, went six wide at the quarter pole and tired. ARROCHA (BRZ) three wide through the opening bend, raced three wide in pursuit, came under coaxing half a mile from home, angled out seven wide into upper stretch and came up empty.
