Free nomination by Saturday, January 15, 2011, \$2,000 to pass the entry box and \$1,000 additional to start, with \$200,000 Guaranteed. All fees shall be paid prior to the start of the race. The owner of the winner to receive \$120,000, \$40,000 to second, \$20,000 to third, \$10,000 to fourth, \$6,000 to fifth and \$4,000 to sixth. Supplemental nominations may at time of entry at a fee of \$10,000, which includes entry and starting fees. Weight: 122 lbs. POMEROYS PISTOL pressed the pace along the inside, moved to take over midway of the turn, opened a clear lead in the stretch, then drifted out through the final eighth and lasted over DANCINGINHERDREAMS. The latter, reserved off the pace, swung wide at the top of the stretch, then responded to pressure and was gaining on the winner at the finish. EVIL QUEEN unhurried early, advanced along the rail to reach contention in the stretch but had no further response. R HEAT LIGHTNING bumped with THIRD CHANCE at the start, chased the leaders four wide around the turn, then gave way. THIRD CHANCE bumped with R HEAT LIGHTNING at the start, set the pace under pressure outside POMEROYS PISTOL to midway of the turn, then tired. DEVILISH LADY raced with the pace three wide to midway of the turn, then faltered. ALEXANDRA RYLEE chased the pace five wide into the turn and faded.
