UPSTART was reserved just off the leaders early, moved outside through the second turn, was bumped by FROSTED in mid-stretch, drifted out through the final sixteenth and drew clear late. ITSAKNOCKOUT settled just off the leaders early, moved outside through the second turn, drifted in and was quickly straightened away nearing the eighth pole, was carried out by the winner and checked through the final sixteenth and lost best chance. FRAMMENTO lagged early, raced wide through the second turn, angled out further into the stretch and finished full of run. FROSTED pressed the pace of BLUEGRASS SINGER from the outside, moved up engage nearing the half, opened a clear lead nearing the five-sixteenths pole, drifted out to bump UPSTART in mid-stretch and gave way through the final furlong. GORGEOUS BIRD raced off the pacesetters early, moved outside through the second turn and failed to threaten. BLUEGRASS SINGER sprinted clear at once, saved ground while setting the pace, responded when challenged by FROSTED nearing the half, vied with that rival and gradually gave way in the drive. JUAN AND BINA was forwardly placed from the inside throughout and weakened in the drive. DANNY BOY was void of early speed, saved ground throughout and did not reach contention. THE RIDER OF ITSAKNOCKOUT LODGED AND OBJECTION AGAINST UPSTART CONCERNING THE STEADYING OF HIS MOUNT AT THE SIXTEENTH POLE AND AFTER REVIEWING THE FILMS THE STEWARDS CONCLUDED UPSTART HAD CONTINUED TO DRIFT OUT CAUSING ITSAKNOCKOUT TO BE CARRIED OUT AND STEADIED AND DISQUALIFIED UPSTART FROM FIRST AND PLACED HIM SECOND.
