1 1/8 MILE. (1:40) STAKES. Purse \$400,000 Xpressbet Fountain of Youth S. (Grade II) THREE YEAR OLDS. Free nomination by Sunday, February 17. \$4,000 to enter. \$400,000 Guaranteed. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 122 lbs. Non-winners of a graded stakes allowed 2 lbs.; a stakes, 4 lbs.; two races other than maiden, claiming, or starter, 6 lbs. Starters to be named by usual time of closing. Supplemental nominations may be made at time of entry. All fees shall be paid prior to the start of the race. This race will be limited to 14 starters, with also eligibles. Preference will be given to graded stakes winners, then by highest career earnings. (Clear 81)

**Chestnut Colt, (Mg), by Noble Mission (GB) - Reunited by Dixie Union. Trainer Claude R. McGaughey III. Bred by W. S. Farish (KY).**

CODE OF HONOR gained contending position out of gate, settled nicely being rated path off the inside, commenced steady advance upon entering far turn, moved up closer along inside at quarter pole then quickly angled out turning for home, given cue and roused forward to challenge HIDDEN SCROLL, vied for the lead then took control and kept clear. BOURBON WAR raced off the pace and saved ground, picked up pace midway through backstretch then driving two wide past the quarter pole, raced six path upper stretch, continued to gather momentum and produced solid finish closing on winner. VEKOMA rated off the clear trio through early stages then picked up the pace at half mile marker, quickly advance on three wide run in final turn then drifted in upper stretch, switched out when urged left handed, appeared all out but continued to try and lasted for share. HIDDEN SCROLL got bumped off stride and lost couple steps at start, vied for the lead with GLADIATOR KING in first turn, continued to set pressured pace on top then cleared over rival, continued to hold off challengers in final turn, appeared all out when CODE OF HONOR moved up to challenge upper stretch but continued to fight back gamely then had nothing left in late reserve. GLOBAL CAMPAIGN forwardly placed off top two leaders racing clear over next pursuer, launched bid for HIDDEN SCROLL upon entering far turn, could not reach rival then flattened out past the quarter pole. UNION'S DESTINY fanned seven wide entering first turn, continued off the pace racing along outside, driving outside position entering stretch and passed tiring foes. SIGNALMAN saved ground racing off the pace, hustled up along rail in final turn, took closer order but failed to sustain bid and weakened in the lane. EVERFAST raced five wide entering first turn, unhurried through backstretch, hustled up three wide through far turn, failed to kick on. EPIC DREAMER rated through early stages, urged three to four wide in final turn but failed to move on. FROSTED GRACE fanned six wide entering first turn, raced in the back and failed to gain close contention. GLADIATOR KING vied for the lead with HIDDEN SCROLL in first turn, continued to press the pace through early stages then retreated after half.
