By subscription of \$50 each which shall accompany the nomination, \$500 to pass the entry box and an additional \$500 to start - with \$50,000 guaranteed and an additional \$20,000 from the F.T.B.O.A Fund. The Owner of the winner to receive 60%, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. The F.T.B.O.A. monies will be correspondingly divided provided a Registered Florida Bred has finish in an awarded position. Weight: 121 lbs. E B RYDER unhurried after breaking slowly, swung out for the stretch run, then rallied to take over at the sixteenth pole and edged away. TRIPLE ARCH allowed to settle, saved ground around the far turn and rallied along the hedge for the place. DREAMING OF SOPHIA rated off the pace, advanced around the far turn to reach the attending position in the stretch and continued on with good courage for the show while being outfinished by the top ones. SHE'S SPOOKY chased the pace off the rail, moved to take over leaving the far turn, made the pace to the sixteenth pole, then weakened. PUTYOURDREAMSAWAY set the early pace along the inside, stalked the leaders into the stretch after losing the advantage, then gave way in the final eighth. NICKI STARSHINE outran after bumping with JADE'S RAINBOW at the start, made a run three wide around the far turn to reach contention, then tired in the drive. JADE'S RAINBOW failed to menace after being bumped and steadied from between rivals at the start. BURNING TRUTH was no factor after being checked while trying to get out on the first turn. DREAMLICIOUS raced in striking position into the far turn and faltered. LOVE TO SCORE outran PUTYOURDREAMSAWAY for the lead down the backstretch, made the pace along the inside to nearing the top of the stretch, then faded. PUTITINMYPOCKET was outran after being steadied when she bumped with JADE'S RAINBOW at the start. FOUR ARIA was through after a half mile.
