By subscription of \$100 each to accompany the nomination, closed Saturday, February 27, 2016 with 19 or by supplementary nomination of \$8,000 by time of entry. \$1,000 to enter, \$5,000 additional to start, with \$400,000 guaranteed, of which \$240,000 to first, \$80,000 to second, \$48,000 to third, \$24,000 to fourth and \$8,000 to fifth. Weight 124 lbs. Non-winners of a Grade I stake at One Mile or Over since September 12, 2015, allowed 3 lbs.; Non-winners of a Grade I stake at One Mile or Over OR Two Grade II stakes since March 12, 2015, allowed 5 lbs. A trophy will be presented to the winning owner. (Clear 65)

WHAT A VIEW sped to the early lead, set all the pace along the inside, inched away on the second turn and drew clear in the stretch under urging then steady handling late. BOLO chased a bit off the rail, came out on the second turn and four wide into the stretch and edged a rival for the place. BAL A BALI (BRZ) stalked the pace between horses then inside on the second turn, drifted out despite right handed urging and bumped with a rival a sixteenth out and was edged for second. MIDNIGHT STORM close up stalking the pace three deep then between horses into the stretch continued between foes, drifted in despite left handed urging and bumped with a rival then steadied a sixteenth out, drifted to the inside in the late stages and could not offer the necessary response. KENJISSTORM three deep early, stalked a bit off the rail then between horses into the stretch, dropped back and drifted to the inside in midstretch and weakened. OM had speed inside then steadied in tight into the first turn, saved ground stalking the pace, dropped back on the second turn, came out into the stretch and also weakened, then was not persevered with late. The stewards conducted an inquiry into the run past midstretch of the third and fourth finishers but made no change when they ruled both runners contributed to the contact between them and that MIDNIGHT STORM was more responsible.
